- Grievant: Grievant means a student, parent, staff member or group of students or parents or staff members submitting the grievance.

POLICY AND GUIDELINES

As per the regulations of the university governing council, the affiliated colleges are instructed to start a Grievance Redressal committee for students (GRCS). The Cell ensures effective solution to the grievances, using a fair approach. The Grievance and Redressal Cell enables the students to express their grievances by initiating and following the grievance procedure in accordance with the rules and regulations of the College. The cell meets periodically, examines the nature and pattern of the grievances and redresses it accordingly.
